Mumbai's Party-Wise Manifesto (2017-22) Analysis & Targets to Set for 2022-2027





- 8,934 questions were raised by all councillors from 2017-18 to 2020-21.
- 1,222 number of question from 2017-18 to 2020-21, was on naming and renaming of roads/chowks/building etc.

Brief Insights on Some Manifesto Promises from 2017-2022

- Shiv Sena had promised pothole free Mumbai with new technology and material, however, in F.Y. 2017-18 to 2020-21, **17,908 complaints were related to** potholes.
- BJP had promised 24/7 water supply, however, 204 out of 290 zones received only up to 4 hours of water supply in 2020.
- Despite BJP, NCP and INC promising a policy for hawkers and special zones for hawkers & other street vendors, 34,129 hawker related complaints were registered from F.Y. 2017-18 to 2020-21.



An election manifesto has the following uses:

- It enables voters to know about policies & services the party aims to implement
- Allows citizens to track status of implementation of various policies and programmes promised during elections



Praja aims to provide a brief analysis on the commitments made with:

- Deliberations on the civic issues and services only mentioned in the manifesto.
- Major complaints registered by citizens of Mumbai from 2017-18 to 2020-21

Bilateral and national targets such as Sustainable Development Goals, Urban Design Plan Formulation and Implementation standards, Swachh Bharat Mission guidelines and the 74th CAA should be studied by political parties and included in their manifesto.

This will ensure Mumbai city government is Democratically Empowered to provide quality and efficient services.

BJP promised **24 hour water supply**, **however, average timing of water supply in 2020 was only 5.39 hours**.

From 2017 to 2021, on an average, INC councillors asked 12 questions on water supply each year, while NCP councillors asked only 1 question each year.

- All parties promised to improve the condition of roads in Mumbai. However, from 2017-18 to 2020-21, a total of 46,235 road related complaints were registered, of which 39% were for bad patches and/or potholes on the roads.
- In 4 years only 69 questions were, in total, on issues related potholes.

- In 202, 34,129 complaints were related to Hawkers.
- To address this, a total of 128 questions were asked by all councillors from 2017-18 to 2020-21, an average of 32 questions each year.

 The Hawkers Policy is yet to be implemented in Mumbai, hence more effective and targeted deliberations must be carried out to ensure policy implementation is not stalled.

Targets & Reforms to Set For 2022-2027



Empowered Mayor

 Office of the Mayor should be coterminous with the term of the City Government to synchronize planning, execute projects envisioned and ultimately fulfil citizens' mandate by the office of the mayor.

Single Authority

- 74th CAA has recommended the State Governments to devolve 18 functions listed in the Twelfth Schedule to the City Governments.
- All agencies should also be under the direct control of the Mayor.

Train Human Resources

- Local governments must hold extensive capacity building and training workshops for the administration and elected representatives alike.
- A system in place to gauge the performance of employees and hold accountable for their actions



Devolution of financial power

- The City Government should hold independent authority to introduce & revise taxes/charges.
- Provision for the City Government budget to include budget allocated by parastatal agencies in the city.

Systemic Fiscal transfers

 The State Finance Commission (SFC) reports and the action taken on them should be available on the official website of the state government.


Financial accountability

- The State Municipal Act should make it mandatory to publish the budget and accounts in the city government's website.
- The State Municipal Act should have provisions for conducting external audit.

Strengthen Citizen Participation



Ideal Citizen Journey



Citizen Participation Forum

A platform that allows citizens to express their needs and wants. The platform can be regularly monitored by all stakeholders to ensure citizen centric approach when planning for service delivery and infrastructure provisions in cities. Adding this aspect will bring the citizen journey to completion.

"A 'citizen journey' is the entire experience that a person has when seeking a government service. The journey has a discrete beginning and end, and because it is typically multitouch and multichannel, it is also cross-functional in nature. A citizen journey is anchored in how people think about their experience, not in how government agencies do."

Inclusive Development Plan





- A local Area Development (LAD) plan should be formulated for targeted planning outcomes
- The SDG 11: Sustainable Cities and Communities targets to promote safe and affordable housing as well as safe, inclusive and accessible, green public spaces for all.
- Decade of Action for Road Safety 2021-2030 promotes walking, cycling and using public transport as inherently healthy and environmentally sound modes of transport.

Comprehensive Health Plan



Status in Mumbai

- Cause of Death data has been unavailable since January 2020.
- 44% vacant post in medical staff (directly treating patients), 45% and 20% vacant post are in para-medical and nursing staff respectively as on 2020.
- Out of the 187 public dispensaries, 170 dispensaries are open for only 7 hrs up to 4pm.



- All health data should be maintained and analysed on a real-time basis.
- NBC and UDPFI recommends 1 dispensary for every 15,000 population.
- The SDG 3: Good health and wellbeing targets should be incorporated in all policy planning.



Status in Mumbai

- In 74% of schools in 2018-19, councillors did not attend even one SMC meeting.
- 1,74,464 school children were screened under the School Health Scheme in 2019-20 and these children suffered from 1,97,889 total health defects.
- However, for 2020-21, RTI reply received by the MCGM department for the scheme, mentions "zero" children were screened during the pandemic.


- The SDG 4: Quality Education targets to ensure free, equitable and quality primary and secondary education leading to relevant and effective learning outcomes should be achieved.
- Focus on strengthening the SMC and encourage participation.
- Regular health check-ups with 100% coverage of all school students should be carried out.

Improved Coverage of Water and Sewerage



Status in Mumbai

- 33% of 11,855 water related complaints were of shortage of water in 2020.
- In 2019-20, however, 12% of 11,855 water complaints in 2020 were related to contamination.
- There is 4% non metered connections (includes residential, industrial and commercial) in 2020.



- BIS standard of 135lpcd must be supplied
- Implement MCGM's goal of 100% metering & MCGM 24/7 water supply project
- The SDG 6: Clean water and sanitation targets to provide universal and equitable access to safe and affordable drinking water for all


- The average maximum BOD recorded in all the major beach outlets was 19mg/lt. in 2019. (CPCB norm is <3mg/lt.)</p>
- The maximum BOD of Mithi river was 50mg/lt. (compared to the norm of <3mg/lt.)</p>

- 100% of Sewerage generated should be treated
- Treated Water will be reused for various purposes

Better Provision of Toilets & Effective Solid Waste Management (SWM)

Status in Mumbai

- There is currently 1 community toilet seat per 42 males and 34 females.
- Only 1 in 4 public toilets were for women in 2020.



- Swachh Bharat Mission (SBM) guidelines for all public and community toilets should be implemented.
- 100% water and sewerage connection in all public and community toilets.

- Out of the total 11,595 SWM complaints in 2020, 34% were related to garbage not being collected.
- Deonar dumping ground has been functional way beyond the prescribed active landfill lifespan of 10 to 25 years.

- The SBM guidelines for SWM must be incorporated.
- All waste generated must be recovered at ward level so waste sent to dumping grounds can be reduced and eventually eradicated.

Targets for Improved and Better Service Delivery





Maintain Accurate Environment Reports

- Municipal act 1888, makes "Environment Protection, Promotion of Ecology and Urban Forestry" as an obligatory duty vide section 61 (a b) in the year 1994.
- The Environment Status Report (ESR) is an obligation under the clause '63 B' of Mumbai Municipal Corporation (MMC) Act 1888 & MCGM must publish this report on time and with accurate and researched data and information.



Pothole Free Mumbai

Decade of Action for Road Safety 2021-2030 targets.

- Preventing at least 50% of road traffic deaths and injuries by 2030.
- Emphasising the importance of a holistic approach to road safety, and calling on continued improvements in the design of roads and vehicles; enhancement of laws and law enforcement; and provision of timely, life-saving emergency care for the injured.



Improve Livelihood

> The SDG 1: No poverty targets to end poverty in all forms by 2030.

The SDG 8: Decent work and economic growth targets to Protect labour rights and promote safe and secure working environments for all workers, including migrant workers, in particular women migrants, and those in precarious employment by 2030.
